



"Riding helps me do my [school] work a lot. Some things are hard for me, like math and reading, and when I get frustrated, I think about the horses. That makes me feel better," shares nine-year-old Deborah Busch.

Her mom, Jessica, adopted her out of foster care three years ago. "Deborah suffered from extreme abuse and neglect," she explains. "When I got her, she was six but she could barely talk and she had no core strength. It was hard just to lift her into the car. She was that floppy."

Jessica delights in Deborah's success riding. "Listening and paying attention are a real struggle, and she has memory problems from the fetal alcohol syndrome. Riding is what's fun for Deborah, and it's so important that she has something fun in her life. She needs so much support in everything else she does, but it's like she's a different kid on the horse. . . Riding just flows out of her."
